ADOPTION ORGANIZATION'S RESPONSIBILITIES

Southeast Alaska Organization for Animals, Ltd (hereafter referred to as "SOFA"), agrees to the following terms and provisions:

1. SOFA will provide a cat that has been examined by a licensed veterinarian, received core vaccinations as required by organization bylaws, dewormed, treated for fleas/ticks if necessary, and microchipped. Medical history and treatment records will be provided upon successful adoption, and the Trial run applicant will be notified of any known history of medical or behavioral issues before the Trial run begins. SOFA makes no representations or warranties about the condition, personality, or temperament of the Cat and does not guarantee the Cat's temperament or compatibility with the Trial run applicant other members of the household.
2. **If the Trial run is unsuccessful and the Applicant is unable or unwilling to keep the Cat for any reason, SOFA agrees to accept the return of the Cat with immediate effect to a registered Foster home.**
3. **SOFA will provide all required and/or needed veterinary care during the Trial run.**
4. SOFA agrees to notify the Applicant of any change of contact information (address, phone number, and/or email address) within two (2) weeks.

TRIAL RUN APPLICANT'S RESPONSIBILITIES

*PLEASE NOTE: Please read the following carefully. If there is/are any condition(s) that you are unwilling or unable to comply with, please notify the SOFA Representative **now**. This agreement may be modified to make allowances for special circumstances for committed, responsible applicants, if a reasonable alternative can be identified.*

The Applicant agrees to the following terms and provisions:

1. The Cat is being temporarily transferred to the Applicant with the understanding that he/she is taking temporary possession of the Cat to treat and to be responsible for it as his/her own Cat on a Trial run basis. The Applicant assumes all legal risks and obligations of ownership and agrees to defend, indemnify, and hold SOFA harmless for any loss of, damage to, or injury to persons, animals or property caused by the Cat.
2. The Applicant will do his/her best to ensure the Cat safety and well-being, including but not limited to:
 - a. The Applicant will feed the Cat adequate **nutritious, species- and age-appropriate food and clean, fresh water** to maintain good health and normal development; provide the Cat with a **safe, clean environment and access to shelter** at all times; and allow for adequate **daily exercise** in accordance with state and local laws and ordinances to maintain the physical and mental health of the Cat.
 - b. **The Applicant will never let the Cat run loose or roam off of the Applicant's personal property.** The Applicant will ensure compliance with all applicable state and local laws and ordinances regarding care and control of animals.
 - c. The Applicant will ensure that the Cat is wearing a **break-away collar at all times** with an up-to-date **identification tag** and/or appropriate license attached. The collar should be fitted so that it does not cause pain, injury, or risk of injury to the Cat.
